2 SECTION 44. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 4 APPROPRIATION AND FUND TRANSFERS. After receiving approval from the Chief 5 Fiscal Officer of the State, the Director of the Arkansas Economic 6 Development Commission is authorized to transfer appropriation and funds from 7 the Division of Science and Technology State Operations - Arkansas 8 Acceleration Fund Programs line item within the Arkansas Economic Development 9 Commission Fund Account to the Arkansas Acceleration Fund. The Rural Services Division of the Arkansas Economic 9 Development Commission shall promulgate rules establishing the criteria to be 10 utilized in determining to whom grants will be made under this Act. Subject to the approval of the Governor, and approval by the Arkansas Legislative 11 12 Council or the Joint Budget Committee, the Rural Services Division of the 13 Arkansas Economic Development Commission shall distribute the grants.

14 Determining the maximum number of employees and the maximum amount of 15 appropriation and general revenue funding for a state agency each fiscal year 16 is the prerogative of the General Assembly. SECTION 47. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

SECTION 52. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 53. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits

the appropriation of funds for more than a one (1) year period; that the

effectiveness of this Act on July 1, 2025 is essential to the operation of

the agency for which the appropriations in this Act are provided, and that in

the event of an extension of the legislative session, the delay in the

effective date of this Act beyond July 1, 2025 could work irreparable harm

upon the proper administration and provision of essential governmental

programs. Therefore, an emergency is hereby declared to exist and this Act

being necessary for the immediate preservation of the public peace, health

- and safety shall be in full force and effect from and after July 1, 2025.
