14	TO AMEND THE LAW CONCERNING THE
15	LICENSURE OF ELECTRICAL INSPECTORS.
16	
17	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
18	
19	SECTION 1. Arkansas Code § 17-55-101(b), concerning applications for
20	licensure as an electrical inspector, is amended to read as follows:
21	(b)(l) A person shall apply for licensure as an electrical inspector
22	on a form approved by the board within thirty (30) days of employment as an
23	electrical inspector.
24	(2) A person shall be eligible to apply for licensure as an
25	electrical inspector if he or she is a:
26	(A) Master electrician;
27	(B) Journeyman electrician;
28	(C) International Code Council Electrical Inspector with
29	six (6) months of employment experience at a municipal building code
30	enforcement office;
31	(D) Arkansas Fire Training Academy International Fire
32	Service Accreditation Congress Inspector 1 with two (2) years of employment
33	experience at a fire marshal's office or fire inspector's office;
34	(E) Arkansas Fire Training Academy International Fire
35	Service Accreditation Congress Inspector 2 with one (1) year of employment
36	experience at a fire marshal's office or fire inspector's office; or



1	(F) Arkansas Fire Training Academy International Fire
2	Service Accreditation Congress Inspector 3 with six (6) months of employment
3	experience at a fire marshal's office or fire inspector's office.
4	(2)(3) Applications shall be made to the board and shall contain:
5	(A) Proof of employment with the state or a political
6	subdivision of the state as an electrical inspector in the State of Arkansas;
7	(B)(i) Verification of work experience as required by rule
8	of the board.
9	(ii) Work experience shall include without
10	limitation demonstrated knowledge of:
11	(a) The standard materials and methods used in
12	the installation of electric equipment;
13	(b) Approved methods of construction to ensure
14	the safety of persons and property; and
15	(c) The requirements of the statewide
16	standards for the construction, installation, and maintenance of electrical
17	facilities and the performance of electrical work under § 20-31-104; and
18	(A) Proof of:
19	(i) Licensure as an electrician required under
20	subdivisions (b)(2)(A) and (B) of this section; or
21	(ii) Certification and experience required under
22	subdivisions (b)(2)(C)-(F) of this section; and
23	(C)(B) Payment of a license fee as established by rule of
24	the board that shall not exceed fifty dollars (\$50.00).
