19	SECTION 1. Arkan	nsas Code Title 5, Chapter 36, Subch	napter 1, is amended
20	to add an additional section to read as follows:		
21	5-36-127. Theft of Equipment Rental Services.		
22	(a) As used in	this section, "equipment rental serv	rice" means the
23	commercial service of providing equipment for rent or lease.		
24	(b) A person commits the offense of theft of equipment rental services		
25	if he or she knowingly	<u>:</u>	
26	(1) After	the expiration of a lease or rental	period, exercises
27	unauthorized control or	r otherwise deprives the lessor or r	enter of equipment
28	that is leased, rented	, or entrusted to the person; or	
29	<u>(2) Causes</u>	s damage to equipment that is leased	l, rented, or
30	entrusted to the person	n such that the equipment is not in	a condition to be
31	provided for rent or le	ease without repair.	
32	(c) It is a defe	ense to prosecution under this secti	on that the person
33	compensated the lessor	or renter of the equipment for:	
34	<u>(1) The va</u>	alue of the equipment rental service	for the time
35	between the expiration	of the lease or rental period and t	the return of the
36	equipment to the lesson	r or renter; and	

1	(2) The value of any damage to the equipment.		
2	(d) A violation of this section is a:		
3	(1) Class B felony if the value of the equipment rental service		
4	for the time between the expiration of the lease or rental period and the		
5	return of the equipment, the damage to the equipment, or both, is twenty-five		
6	thousand dollars (\$25,000) or more;		
7	(2) Class C felony if the value of the equipment rental service		
8	for the time between the expiration of the lease or rental period and the		
9	return of the equipment, the damage to the equipment, or both, is less than		
10	twenty-five thousand dollars (\$25,000) but more than five thousand dollars		
11	<u>(\$5,000);</u>		
12	(3) Class D felony if the value of the equipment rental service		
13	for the time between the expiration of the lease or rental period and the		
14	return of the equipment, the damage to the equipment, or both, is five		
15	thousand dollars (\$5,000) or less but more than one thousand dollars		
16	<u>(\$1,000);</u>		
17	(4) Class A misdemeanor if the value of the equipment rental		
18	service for the time between the expiration of the lease or rental period and		
19	the return of the equipment, the damage to the equipment, or both, is one		
20	thousand dollars (\$1,000) or less.		
21	(e) In addition to any other sentence authorized by law, the court		
22	shall order a person convicted of theft of rental services to pay restitution		
23	to the lessor or renter of the equipment for the value of the equipment		
24	rental service for the time between the expiration of the lease or rental		
25	period and the return of the equipment and any damage to the equipment.
