25	Assem	ably, that the Constitution of the State of Arkansas	prohibits the

27	effec	tiveness of this Act on July 1, 2025 is essential t	o the operation of			
28	the a	gency for which the appropriations in this Act are	provided, and that in			
29	the e	event of an extension of the legislative session, th	e delay in the			
30	effec	tive date of this Act beyond July 1, 2025 could wor	k irreparable harm			
31	upon	the proper administration and provision of essentia	<u>l governmental</u>			
32	progr	ams. Therefore, an emergency is hereby declared to	exist and this Act			
33	being	necessary for the immediate preservation of the pu	blic peace, health			
34	and s	safety shall be in full force and effect from and af	ter July 1, 2025.
