16	TO AMEND THE INFORMATION THAT A SCHOOL

21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code § 6-11-129(a)(1), concerning the require	ement
24	that school districts make certain information easily identifiable and	
25	accessible, is amended to read as follows:	
26	(a)(1) Each school district shall make the following information	and
27	data easily identified on its website or the website of the school distr	cict's
28	education service cooperative, if the education service cooperative main	ıtains
29	the school district's website:	
30	(A) Current comprehensive financial data reports for	
31	school districts, including:	
32	(i) Local and state revenue sources;	
33	(ii) Administrator and teacher salary and benef	it
34	expenditure data;	
35	(iii) School district balances, including legal	Ĺ
36	balances and building fund balances;	

1	(iv) Minutes of regular and special meetings of the
2	school district board of directors that shall be posted no later than twenty
3	four (24) hours following the adjournment of a regular or special meeting of
4	the school district board of directors;
5	(v) The school district budget for the ensuing year
6	which shall be posted on the website within thirty (30) days following the
7	date required to be submitted to the Division of Elementary and Secondary
8	Education;
9	(vi) A financial breakdown of monthly expenses of
10	the school district;
11	(vii) Salary schedules for all employees, including
12	extended contract and supplementary pay amounts;
13	(viii) Current contract information with all school
14	district employees, except that Social Security numbers, telephone numbers,
15	personal addresses, or signatures shall not be published;
16	(ix) The annual budget of the school district; and
17	(x) The annual school district statistical report;
18	and
19	(xi) Agendas of regular and special meetings of the
20	school district board of directors that shall be posted no later than twenty
21	four (24) hours before each regular or special meeting of the school distric-
22	board of directors; and
23	(xii) The names and email addresses of all members
24	of the school district board of directors, including the respective
25	positions, if zoned, and terms of office of the members of the school
26	district board of directors; and
27	(B) Each school district's personnel policies required
28	under § 6-17-201 et seq. and § 6-17-2301 et seq.
