23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
26 for the Department of Human Services - Division of Developmental Disabilities
27 Services for the 2026-2027 fiscal year, the following maximum number of
28 regular employees.

5 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for
 6 the Department of Human Services - Division of Developmental Disabilities
 7 Services for the 2026-2027 fiscal year, the following maximum number of part-
 8 time or temporary employees, to be known as "Extra Help", payable from funds
 9 appropriated herein for such purposes: one hundred ninety-nine (199)
 10 temporary or part-time employees, when needed, at rates of pay not to exceed
 11 those provided in the Uniform Classification and Compensation Act, or its
 12 successor, or this act for the appropriate classification.

14 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,
 15 to the Department of Human Services, to be payable from the paying account as
 16 determined by the Chief Fiscal Officer of the State, for personal services
 17 and operating expenses of the Department of Human Services - Division of
 18 Developmental Disabilities Services for the fiscal year ending June 30, 2027,

 35 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

1 DEVELOPMENTAL DISABILITIES - GRANTS TO COMMUNITY BASED PROVIDERS. Funds
2 allocated for community-based services under the appropriation for (i) the
3 Grants-in-Aid appropriation in this act, (ii) the Grants/Patient Services
4 Line in the Operations appropriation in this act, and (iii) the Inter-
5 Divisional Programs appropriation in this act, shall be used only to provide
6 services through private community based services licensed or certified by
7 the Arkansas Division of Developmental Disabilities Services (DDS) or
8 licensed or certified by a Provider-Led Arkansas Shared Savings Entity
9 (PASSE). Non-profit community-based programs licensed by the Division of
10 Developmental Disabilities Services are quasi-governmental instrumentalities
11 of the state which provide supports and services to individuals who have a
12 developmental disability or delay, who would otherwise require supports and
13 services through state-operated programs and facilities owned by the State of
14 Arkansas. When licensed providers are involved in delivering services which
15 are Medicaid reimbursable, they must enroll as a provider with the Arkansas
16 Medicaid Program and must bill the Arkansas Medicaid Program for all covered
17 services for eligible individuals.

18 Services which are covered by the Arkansas State Medicaid Program,
19 including the Provider-Led Arkansas Shared Savings Entity (PASSE) model, will
20 be utilized to the maximum extent possible for any individual who is eligible
21 for Medicaid coverage. It is the intent of this section that DDS, as a
22 general policy, maximize the use of Medicaid funding available for
23 appropriate services.

24 Licensed private community providers funded from these appropriations for
25 community based services shall:

- 26 1. Screen each individual to whom services are provided for a determination
27 of eligibility or ineligibility for Medicaid coverage within thirty days of
28 the first date that services are provided.
- 29 2. Meet minimum standards of performance in the delivery of services to
30 people with disabilities as defined by the Department of Human Services -
31 Division of Developmental Disabilities Services.
- 32 3. Supply statistical and financial data to the Department of Human Services
33 - Division of Developmental Disabilities Services.
- 34 4. Establish and maintain a sound financial management system in accordance
35 with guidelines as set forth by the Department of Human Services.
- 36 5. Establish and maintain community support programs designed to provide

1 coordinated care and treatment to ensure ongoing involvement and
2 individualized services for persons with disabilities.
3 It is the intent of this section to insure that wherever possible and
4 appropriate, Medicaid funds are utilized.

5 Nothing in this Act shall prevent the Division or any provider from
6 extending emergency services when appropriate measures have been taken in a
7 timely manner to secure Medicaid eligibility.

8 The provisions of this section shall be in effect only from July 1, ~~2025~~
9 2026 through June 30, ~~2026~~ 2027.

10

11 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.

13 ELIMINATION OF AUTISM WAIVER SERVICES WAITING LIST. Immediately upon the
14 effective date of this Act, the Department of Human Services - Division of
15 Developmental Disabilities Services shall budget, allocate, and expend up to
16 one million dollars (\$1,000,000) for the elimination of the Autism Waiver
17 Services Program waiting list.

18 The provisions of this section shall be in effect only from July 1,
19 ~~2025~~ 2026 through June 30, ~~2026~~ 2027.

20

21 SECTION 12. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
22 authorized by this act shall be limited to the appropriation for such agency
23 and funds made available by law for the support of such appropriations; and
24 the restrictions of the State Procurement Law, the General Accounting and
25 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
26 Procedures and Restrictions Act, or their successors, and other fiscal
27 control laws of this State, where applicable, and regulations promulgated by
28 the Department of Finance and Administration, as authorized by law, shall be
29 strictly complied with in disbursement of said funds.

30

31 SECTION 13. LEGISLATIVE INTENT. It is the intent of the General
32 Assembly that any funds disbursed under the authority of the appropriations
33 contained in this act shall be in compliance with the stated reasons for
34 which this act was adopted, as evidenced by the Agency Requests, Executive
35 Recommendations and Legislative Recommendations contained in the budget
36 manuals prepared by the Department of Finance and Administration, letters, or

1 summarized oral testimony in the official minutes of the Arkansas Legislative
2 Council or Joint Budget Committee which relate to its passage and adoption.

3
4 SECTION 14. EMERGENCY CLAUSE. It is found and determined by the
5 General Assembly, that the Constitution of the State of Arkansas prohibits
6 the appropriation of funds for more than a one (1) year period; that the
7 effectiveness of this Act on July 1, 2026 is essential to the operation of
8 the agency for which the appropriations in this Act are provided, and that in
9 the event of an extension of the legislative session, the delay in the
10 effective date of this Act beyond July 1, 2026 could work irreparable harm
11 upon the proper administration and provision of essential governmental
12 programs. Therefore, an emergency is hereby declared to exist and this Act
13 being necessary for the immediate preservation of the public peace, health
14 and safety shall be in full force and effect from and after July 1, 2026.
