21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established
24 for the Arkansas Supreme Court for the 2026-2027 fiscal year, the following
25 maximum number of regular employees.

25 the Arkansas Supreme Court for the 2026-2027 fiscal year, the following

26 maximum number of part-time or temporary employees, to be known as "Extra

27 Help", payable from funds appropriated herein for such purposes: five (5)

28 temporary or part-time employees, when needed, at rates of pay not to exceed

29 those provided in the Uniform Classification and Compensation Act, or its

30 successor, or this act for the appropriate classification.

32 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated,

33 to the Arkansas Supreme Court, to be payable from the State Central Services

34 Fund, for personal services and operating expenses of the Arkansas Supreme

35 Court for the fiscal year ending June 30, 2027, the following:

17 SECTION 5. EXTRA HELP - SUPREME COURT BAR OF ARKANSAS. There is hereby
 18 authorized, for the Arkansas Supreme Court for the 2026-2027 fiscal year, the
 19 following maximum number of part-time or temporary employees, to be known as
 20 "Extra Help", payable from funds appropriated herein for such purposes: five
 21 (5) temporary or part-time employees, when needed, at rates of pay not to
 22 exceed those provided in the Uniform Classification and Compensation Act, or
 23 its successor, or this act for the appropriate classification.

25 SECTION 6. APPROPRIATION - SUPREME COURT BAR OF ARKANSAS. There is
 26 hereby appropriated, to the Arkansas Supreme Court, to be payable from cash
 27 funds as defined by Arkansas Code §19-4-801, for personal services and
 28 operating expenses for the fiscal year ending June 30, 2027, the following:

9 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 10 authorized by this act shall be limited to the appropriation for such agency
 11 and funds made available by law for the support of such appropriations; and
 12 the restrictions of the State Procurement Law, the General Accounting and
 13 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 14 Procedures and Restrictions Act, or their successors, and other fiscal
 15 control laws of this State, where applicable, and regulations promulgated by
 16 the Department of Finance and Administration, as authorized by law, shall be
 17 strictly complied with in disbursement of said funds.

18

19 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General
 20 Assembly that any funds disbursed under the authority of the appropriations
 21 contained in this act shall be in compliance with the stated reasons for
 22 which this act was adopted, as evidenced by the Agency Requests, Executive
 23 Recommendations and Legislative Recommendations contained in the budget
 24 manuals prepared by the Department of Finance and Administration, letters, or
 25 summarized oral testimony in the official minutes of the Arkansas Legislative
 26 Council or Joint Budget Committee which relate to its passage and adoption.

27

28 SECTION 9. EMERGENCY CLAUSE. It is found and determined by the General
 29 Assembly, that the Constitution of the State of Arkansas prohibits the
 30 appropriation of funds for more than a one (1) year period; that the
 31 effectiveness of this Act on July 1, 2026 is essential to the operation of
 32 the agency for which the appropriations in this Act are provided, and that in
 33 the event of an extension of the legislative session, the delay in the
 34 effective date of this Act beyond July 1, 2026 could work irreparable harm
 35 upon the proper administration and provision of essential governmental
 36 programs. Therefore, an emergency is hereby declared to exist and this Act

1 being necessary for the immediate preservation of the public peace, health
2 and safety shall be in full force and effect from and after July 1, 2026.
