23 BE IT RESOLVED BY THE SENATE OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE
24 STATE OF ARKANSAS:

26 THAT Senator Dismang is authorized to introduce a bill which as
27 introduced will read substantially as follows:

29 "Title

30 AN ACT TO AMEND THE REVENUE STABILIZATION LAW; TO CREATE FUNDS; TO MAKE
31 TRANSFERS TO AND FROM FUNDS AND FUND ACCOUNTS; TO DECLARE AN EMERGENCY; AND
32 FOR OTHER PURPOSES.

34 Subtitle

35 TO AMEND THE REVENUE STABILIZATION LAW; TO CREATE FUNDS; TO MAKE TRANSFERS TO
36 AND FROM FUNDS AND FUND ACCOUNTS; AND TO DECLARE AN EMERGENCY.



1 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

2
3 SECTION 1. The purpose of this act is to amend the Revenue
4 Stabilization Law, § 19-20-101 et seq., to create funds, and to make
5 transfers to and from funds and fund accounts.

6
7 SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
8 General Assembly of the State of Arkansas that changes to the state's fiscal
9 laws must take effect at the beginning of the fiscal year; and that it is
10 necessary for this act to become effective on July 1, 2026, to avoid a lapse
11 in critical and essential services that the state government provides to the
12 citizens of this state at the beginning of the next fiscal year. Therefore,
13 an emergency is declared to exist, and this act being necessary for the
14 preservation of the public peace, health, and safety shall become effective
15 on July 1, 2026."
