29	SECTION 1. Arkansas Code § 5-61-303(3), concerning the definition	n of
30	"medical emergency" within the Arkansas Human Life Protection Act, is a	mended
31	to read as follows:	
32	(3) "Medical emergency" means a condition in which an abor	tion
33	is necessary to preserve the life $\underline{\text{or health}}$ of a pregnant woman whose l	ife <u>or</u>
34	$\underline{\text{health}}$ is endangered by a $\underline{\text{physical}}$ disorder, $\underline{\text{physical}}$ illness, or $\underline{\text{physical}}$	
35	injury, including a life-endangering or health-endangering physical condition	
36	caused by or arising from the pregnancy itself; and

2	SECTION 2. Arkansas Code $\S$ 5-61-304(a), concerning the prohibitions
3	under the Arkansas Human Life Protection Act, is amended to read as follows:
4	(a) A person shall not purposely perform or attempt to perform an
5	abortion except:
6	(1) To to save the life or health of a pregnant woman in a
7	medical emergency;
8	(2) When the pregnancy is the result of incest for which a
9	$\underline{\text{report has been filed with a law enforcement agency or prosecuting attorney's}}$
10	office alleging the offense of incest, § 5-26-202, or the sexual assault of $\underline{a}$
11	minor;
12	(3) When the pregnancy is the result of a rape for which a
13	$\underline{\text{report has been filed with a law enforcement agency or prosecuting attorney's}}$
14	office alleging the offense of rape, § 5-14-103; or
15	(4) In the case of a fetal abnormality incompatible with life.

17	SECTION 3. Arkansas Code $\S$ 5-61-403(3), concerning the definition of
18	"medical emergency" within the Arkansas Unborn Child Protection Act, is
19	amended to read as follows:
20	(3) "Medical emergency" means a condition in which an abortion
21	is necessary to preserve the life $\underline{\text{or health}}$ of a pregnant woman whose life $\underline{\text{or}}$
22	<u>health</u> is endangered by a <del>physical</del> disorder, <del>physical</del> illness, or <del>physical</del>
23	injury, including a life-endangering $\underline{\text{or health-endangering}}$ $\underline{\text{physical}}$ condition
